All the fees are inclusive of the institutional overhead.

The fees are not exhaustive and will be adapted according to the specificities of your study. The protocol and the imaging manual procedure will be sent to the departments.

Any other department not mentioned in this document may be involved in clinical research. Their specific fees will be provided on a case-by-case basis.

 - One-day clinic: 350€ for the monotherapy or 400€ for the combitherapy
 - Pediatric one-day clinic: 375€ for the monotherapy or 500€ for the combitherapy
 - Hospitalization: 1.091€ (Official INAMI price for the Cliniques Universitaires Saint-Luc)
- If not standard of care: technical acts which will be mentioned in a separate budget.
